Sub : Provisional recognition for imparting Higher Secondary Education

Ref : G.O. No. 926-SE/S/3S-21/17(PT-III)/3S/142/13 Dated :

Sir/ Madam,

I am directed by the President, Council to state that your institution has been accorded provisional recognition for introduction of Higher Secondary General Stream Courses w.e.f. 2018-2019 Session for two years on the following conditions:

1. That the institution will not introduce any subject without prior permission of the Council and the institution will not be allowed **initially** to introduce any subject for which they have no duly qualified teacher on pay roll;
2. That the institution will allow the Council to use its buildings, furniture etc, for examination and other academic purposes as and when necessary and the institution will fully co-operate with the Council in respect of above matters in all possible ways;
3. That the institution will collect relevant regulations and circulars regarding admission, migration, registration, examination etc. and 'Samsad Parichiti' from the Council;
4. That the institution will abide by the rules, regulations and provisions of the circulars of the Council from time to time.
5. That the institution will maintain enrolment prescribed by the Council, maximum 275 students and minimum 35 students for Govt. Aided Institution, maximum 500 students and minimum 75 students for self-Financed institution, in a year and will not admit students in excess of the prescribed limit;
6. That the institution will not hold Higher Secondary Classes in the morning or evening. The institution shall arrange for a total number of 39 periods of 45 minutes each per week;
7. That the provisional recognition accorded to the institution may be cancelled/ withdrawn / kept in abeyance if the institution fails to fulfil the above conditions as well as other conditions prescribed from time to time.

10. Till such time the institution


a) Can engage duly qualified teachers solely out of their own resources without putting any liability either on the Council or on the Government against the NO OBJECTION CERTIFICATE issued by the Council signed by the concerned teacher and duly countersigned by the Head of the Institution;

OR

b) Can approach the CSE, WB for engaging duly qualified Retired Teachers as Guest Teachers as mentioned in

G.O. No. 926-SE/S/3S-21/17(PT-III)/3S/142/13 Dated : 14/09/2018.

11. In case of teaching laboratory- based subjects, the institution must submit documents authenticated by the D.I. (SE) of the respective district to the Council for getting permission. If there is no proper laboratory facilities immediately available to the student, the institution will not allowed to enrol the students in those subjects till any documents is received by the Council fulfilling all the stipulated norms and conditions.
12. In offering subject combination, provisions of Council's Admission & Examination Regulations 2006 (with Amendments) should be strictly followed.
13. That the Institution shall not introduce Co-education system without Council's permission and for introduction of the same the Institution shall apply to the Deputy Secretary (Academic) through concerned D.I. of Schools (SE) with the report of DI of Schools.
14. At the time of Renewal of Recognition for further years, the institution must apply in the Council's prescribed proforma along with the requisite papers positively three months prior to the date of expiry of the existing Recognition Memo; failing which the Renewal may not be given and enrolment of students may not be recognised by the Council. If the school applies for renewal of recognition in due time - there is no fees but after due date the late fee is 2000/- per year.
